

Responding to the Inter-departmental Working Group on Gender Recognition

Response Guideline

1. Response method:

- a. Recommend using computer document, because it is convenient for storage and sending through email.
- b. If response is written by hand, and meant to be sent by fax or postal mail, please reserve enough time to avoid delay.
- c. No matter what method you use, please leave a copy, since there will be a Part II of the consultation.

2. Points for attention in responding:

- a. Response could be sent and represented by an individual or an organization (i.e. school, parish, congregation or association)
- b. For convenience and effectiveness in drafting the response, you may refer to the sample letter attached, and take note to the following principles:
 - i. Consider the Church's stance. The Church is fundamentally against the legislation. The Church does not support advocacy for gender recognition, but choose to approach the persons experiencing gender dysphoria with care, tender love, compassion, and mercifulness. The Church supports them, accompany them, and provide them with realistic and positive support as far as possible. The Church does not wish to see these brothers and sisters making decisions that would harm themselves.
 - ii. The writer should refrain from direct copying. When sourcing content from the sample, please change the wordings, incorporate original comment from yourself or your organization, in order to avoid identical responses from different individuals or organizations.(*)
 - iii. Response by organization should be reviewed and approved by the principal of the organization.
 - iv. Use of words should be appropriate and etiquette be observed.
- c. When sending out the response, please request for confidentiality in the response document and the email. If not, the response document and the author's identity might be publicized.

4. Content of the response should have two parts:
 - a. Request extending the consultation period to at least March 31st, 2018.
 - b. Respond to the first issue only.

 - a. Name of the organization or the individual and valid contact information
